The site extends to c. 4.86 acres and is zoned "New Residential" under the Kilcullen Local Area Plan 2014- 2020 which has been extended. Kilcullen is a sought-after small town with the benefit of shops, schools, church and an excellent transportation network with the train service from Newbridge/Sallins stations, bus route and the M9 Motorways, Newbridge/Sallins stations, bus route and the M9 Motorway c. 1 ½ km at Juncton 2 providing a speedy access to the City only c. 40 km southwest of the M50. Surrounding towns include Naas (11 km), Newbridge (8km) and Kildare Town (14 km). Local amenities include a very active canoe club (adjoining site), GAA, rugby, golf, soccer, tennis, swimming, athletics, hockey, horse riding, fishing and racing in Punchestown, Naas and The Curragh.
